<p><u>RADICAL CYSTECTOMY AND ILEAL CONDUIT (MALE)</u></p> <p>THIS INVOLVES REMOVAL OF ENTIRE BLADDER, PROSTATE AND PELVIC LYMPH NODES AND PERMANENT DIVERSION OF URINE TO ABDOMINAL SKIN USING A LOOP OF BOWEL AS A STOMA</p>	<p>µµ- GENERAL/REGIONAL µµ- LOCAL µµ- SEDATION</p>

Serious or frequently occurring risks

<p>COMMON</p> <ul style="list-style-type: none"> - TEMPORARY INSERTION OF A NASAL TUBE, DRAIN, STENT - HIGH RISK OF IMPOTENCE (LACK OF ERECTIONS) - DRY ORGASM WITH NO SEMEN PRODUCED CAUSING INFERTILITY - BLOOD TRANSFUSION REQUIRED <p>OCCASIONAL</p> <ul style="list-style-type: none"> - NEED TO REMOVE THE PENILE URINARY PIPE AS PART OF THE PROCEDURE - BLOOD LOSS REQUIRING REPEAT SURGERY - CANCER MAY NOT BE CURED WITH REMOVAL OF BLADDER ALONE <p>RARE</p> <ul style="list-style-type: none"> - INFECTION OR HERNIA OF INCISION REQUIRING FURTHER TREATMENT - ANAESTHETIC OR CARDIOVASCULAR PROBLEMS POSSIBLY REQUIRING INTENSIVE CARE ADMISSION (INCLUDING CHEST INFECTION, PULMONARY EMBOLUS, STROKE, DEEP VEIN THROMBOSIS, HEART ATTACK AND DEATH.) - DECREASE RENAL FUNCTION WITH TIME <p>VERY RARE</p> <ul style="list-style-type: none"> - DIARRHOEA DUE TO SHORTENED BOWEL / VITAMIN DEFICIENCY REQUIRING TREATMENT - BOWEL AND URINE LEAKAGE FROM ANASTOMOSIS REQUIRING RE-OPERATION - SCARRING TO BOWEL OR URETERS REQUIRING OPERATION IN FUTURE - SCARRING, NARROWING OR HERNIA FORMATION AROUND STOMAL OPENING REQUIRING REVISION - INTRAOPERATIVE RECTAL INJURY REQUIRING COLOSTOMY <p>ALTERNATIVE TREATMENT: RADIATION TREATMENT TO BLADDER, CONTINENT DIVERSION OF URINE WAS DISCUSSED.</p>
